OVERVIEW OF REZEKNE SPECIAL ECONOMIC ZONE DEVELOPMENT PLAN 2014 – 2020

Rezekne Special Economic Zone was founded in April 23rd, 1997 by the Law on Rezekne Special Economic Zone, which will be in force for 20 years – until March 1st, 2017. On March 14th, 2013 the Parliament of Latvia has adopted amendments in Law on Rezekne Special Economic Zone and on March 14th, 2013 it adopted amendment in Law on the Application of Taxes in Free Ports and Special Economic Zones, stating that tax easements in Rezekne SEZ will be applied until December 31st of 2035.

Rezekne SEZ was founded with an aim to promote trade, develop manufacturing and transit as well as export and import of goods through Latvia. Its task is to attract investment for development of manufacturing and development together with creating new places of employment. The functioning of Rezekne SEZ is concentrated upon stimulation of development in Rezekne city, Rezekne region and in whole Latgale region.

In accordance to Article 11.1., point (1) of Law on Rezekne Special Economic Area the functions of Rezekne Special Economic Zone in itself includes creation of Rezekne Special Economic Zone development plan, which corresponds to Law on Rezekne Special Economic Zone and interests of state, municipality and the society.

Term of validity of Rezekne Special Economic Zone development plan 2007 - 2013, which is in force at the moment, was until the end of Year 2013.

The Rezekne Special Economic Zone development plan 2014 – 2020 has been generated by Rezekne Special Economic Zone Administration with support of SIA "Projekts 3i" enterprise, Specialists from Rezekne city and Rezekne region, and entrepreneurs.

Rezekne Special Economic Zone development plan 2007 - 2013 consists of analysis of current situation, strategy of development, a dimensional perspective of development as well as procedure of implementation and supervision.

Analysis of current situation reviews strategic context of Rezekne SEZ, provides description of economic situation in Rezekne city and Rezekne region. This section also makes research on Rezekne Special Economic Zone and indicates Rezekne SEZ strongest and weakest sides as well as possibilities of development and external threat.

Strategy of Development defines development vision and mission of Rezekne SEZ, strategic aims and priorities of it together with plan of action and list of investment projects.

Dimensional perspective provides vision of Rezekne SEZ development.

Procedure of implementation and supervision sets out mechanism of implementation and supervision of a specific document, and divides responsibilities.

VISION AND MISSION OF REZEKNE SEZ DEVELOPMENT

Rezekne Special Economic Zone development plan 2014 – 2020 defines, how Rezekne SEZ will use its resources, strongest sides and possibilities of development, in order to achieve long term strategic aims, which were set out, on basis of Rezekne SEZ vision and mission. Vision outlines the way how Rezekne SEZ would like to become in long term perspective, whereas mission outlines Rezekne SEZ role both in region and on national level.



DIMENSIONAL DEVELOPMENT PERSPECTIVE OF REZEKNE SEZ

Clean territory and high quality technical infrastructure are one of the most important preconditions for effective functioning and progress of RSEZ. In order to successfully compete with other SEZ and attract investors, it is necessary to offer territories, which are attractive for business, with an easy access to it and with developed technical infrastructure. In order to ensure rational implementation of investment, development process of RSEZ territories must be systematic and gradual. The priority must be given territories with the highest potential that have the biggest interest of investors and development of which would give the most favourable effect, including stimulation of development of surrounding territories.

In order to facilitate the development of Rezekne SEZ, four main courses of action have been chosen:

- 1) development and revitalization of existing RSEZ territories;
- 2) development of logistic centres and industrial/technological parks;
- 3) creation of technical and road infrastructure for production companies;
- 4) alteration of the structure of property.
